June 25, 2020

Signing of the final version of the ENEMLOS Partnership Agreement

Activity 9

July 22, 2020

Analyses of the interest survey related to ENEMLOS

On the basis of the Questionary distributed through Activity 7, a number of valuable data has been collected and processed. It has been established that 26 attorneys at law are interested to take part in the ENEMLOS project, which corresponds to positive response rate of 2.8%. An analysis of the collected data enabled composition of particular "personnel lists" that group attorneys according to fields of law of their proficiency, so that they can better respond to the requirements of particular legal clinics gather around these particular fields of law.
